OUT-SOURCING / HIRING OF SECURITY ARRANGEMENTS AT LAHORE ARTS COUNCIL (ALHAMRA) MALL COMPLEX AND CULTURAL COMPLEX, LAHORE

Under PPRA Rules 2014 (Amended) for open competitive bidding, sealed bids are invited from the well reputed and experienced companies / firms engaged in similar nature of job, for provision of Security Arrangements at Lahore Arts Council (Alhamra) Mall Complex and Cultural Complex on yearly basis, starting from the date of signing of the contract. The firm should be registered with SECP, Income Tax, Sale Tax, Punjab Revenue Authority etc.

- **Single Stage:** As per PPRA Rule 2014, Clause .38 (2) (a), single stage two envelop bidding procedure.
- As per PPRA Rules 2014, Clause 35 the undersigned may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
- The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals.
- As per PPRA Rules 2014, Clause 27, the bidders furnish a bid security @ 4 % of the total annual tender amount i.e Rs. 10 Million, including all taxes that become Rs. 400,000/- as Bid Security in the name of "Lahore Arts Council".
- Sealed bids / tenders shall be reached the office of the undersigned on 16.04.2019 (Tuesday) at 01:00 pm and will be opened on the same date at 01:30 pm in the presence of bidders or representative who care to attend.
- In case the date of opening is declared as a public holiday by the government due to any reason, the next official working day shall be deemed to be the date of submission and opening of tenders accordingly. The time and venue shall remain the same.
- As per PPRA Rules 2014, Clause 25, Bidding Document contains detailed information, specification, terms and conditions etc are available to the bidders immediately after the publication of the invitation to bid on all working days (Monday to Friday) from 09:00 am to 05:00 pm against payment of Rs.1000/- (non-refundable) through Bank Draft / Pay Order in the name of Lahore Arts Council from the office of Assistant Director (Admin).
- The quoted prices must be inclusive of all Government taxes.
- No tender documents shall be issued on the date of opening of the tenders.
